AURORA BAR ASSOCIATION T-SHIRTS (For year 2022) The Aurora Bar Association's official T-shirt for is very plain. It is simply the words:

AURORA BAR ASSOCIATION

Font: Times New Roman, bold. Large, so it can be read from a distance.
Black letters on a light colored shirt.
White letters on a dark colored shirt.
Lettering centered on the front of the shirt – the lettering should be located somewhere between your armpits and your belly button.
You can choose any color shirt you like.

FREQUENTLY ASKED QUESTIONS:

Q: WHY WOULD WE NEED T-SHIRTS?

A: The members of the Aurora Bar Association do not all know each other. If we hold an event, for example a Nature Walk, this helps us find the group more easily.

Q: HOW DO I ORDER A SHIRT?

A: We have a make-your-own T-shirt policy. There are many online vendors who offer T-shirts. The prices, quality, type of fabric, available colors and sizes vary. We feel members should be free to get T-shirts they like. You can google-search "Make your own T Shirt" and find a seller that will allow you to make the shirt, and order it online.

Q: DOES IT HAVE TO BE A T-SHIRT?

A: Not necessarily. You could have a polo shirt, sweatshirt, sleeveless T, etc.

Q: DOES THE AURORA BAR ASSOCIATION HAVE A LOGO?

A: No.

However... Aurora means "dawn."

<u>Suggestion</u>: If you want a more interesting shirt, you could add your own photograph, drawing, or painting of a sunrise to your AURORA BAR ASSOCIATION shirt – we don't all have to have identical shirts.

<u>NOTE</u>: Please do not use other people's copyrighted images without obtaining their permission first – we are lawyers, we are supposed to know not to commit copyright infringement.

The Aurora Bar Association is a professional organization – one of our reasons for existence is to promote professionalism in the legal community. If you wear an Aurora Bar Association shirt in public, the shirt will send a public relations message that reflects on the entire Aurora legal community – we ask that you avoid selecting T-shirt images that reflect negatively on our professionalism.

Q: HOW DO I GET A DOCUMENT I CAN USE FOR THE T-SHIRT DESIGN?

A: It should be relatively easy to make a .pdf document that says AURORAL BAR ASSOCIATION yourself. Open a Microsoft Word document, type the words AURORA BAR ASSOCIATION in a very large Times New Roman font, bold, center, and save as .pdf. Most places that sell make-your-own T-shirts should be able to work with that. Or you could print it out onto an iron-on label (available at office supply stores), and make your own shirt. That said, we do have a .pdf document that you can use – contact us and the Aurora Bar Association should be able to send it to you by email.

- Q: DO I HAVE TO WEAR AN AURORA BAR ASSOCIATION SHIRT TO AURORA BAR EVENTS?
- A: No. But if members do wear the shirts, members can find each other more easily.

Q: DOES THE AURORA BAR ASSOCIATION PAY FOR T-SHIRTS?

A: Generally no. We will consider reimbursing members for T-shirts in cases of financial hardship. Please contact a Board member if you are a member who would like to have a T-Shirt but cannot afford one.
