i. Mr. Meseck indicated that the Title Standards Committee is looking for new members and has asked for people to reach out Jim with interest. Mr. Geoff Anderson indicated that they are most interested in someone that has trusts/estates expertise, but they would take others as well. Mr. Anderson indicated that they are looking to fill the spot within the next couple of months.

#### f. Section Council Caucuses

i. Ms. Ham indicated that we were the most represented section. An email is going out for feedback regarding the format and frequency. Ms. Ham will reach out to the Membership and Practice Development Committee and officers to discuss the proposed new member welcome letters. Mr. Meseck will ask the committee to adopt one for our Section. Ms. Ham explained that hybrid attendance options are here to stay for events for most other Sections.

### g. Legal Professionalism Month Proclamation

- i. Mr. Meseck reminded the members that we are here to support the CBA initiatives and is proud of our Section's commitment to professionalism.
- h. Real Estate Section Holiday Party December 6, 2023
  - i. Mr. Meseck noted that everyone should hold open the date for the annual holiday party. Ms. Ham indicated that we might have to change the venue depending on whether they have availability.

#### 6. Action Items:

- a. Miller v. Amos Amicus Brief Filed ........................ Jim Meseck, Deanne Stodden
  - i. Mr. Meseck gave a special thanks to Deanne Stodden, Lyndsey O'Connell, Reagan Larkin, Carolin Topelson, Erin Clark, Miro Kovacevic, and Angie Schmitz for their hard work on the Brief. Mr. Meseck thought that the time and effort put into the brief is a testament to the quality of the people on Section Council.
  - ii. Bar Association Amicus Process: Amicus Committee presentation and vote, then CBA Executive Council approval (Final Vote was 13 in favor, 1 against, and 12 abstentions (6 were due to no response)).
    - 1. Mr. Meseck indicated that the process was multi-layered and further evidences the effort of the Task Force.

#### iii. Summary of additional Amicus Briefs

1. Ms. Deanne Stodden explained that most of the other briefs were limited to policy arguments and somewhat lacking in legal argument. Ms. Carolin Topelson indicated that the statutory change made this legislative

session to eviction proceedings will continue to create issues in cases, and she thinks we need to be ready to propose a fix to the jurisdiction issues involved with this Fair Housing defense.

- b. Buyer Radon Disclosure Form.......Jim Meseck
  - i. Mr. Damien Cox presented the Buyer Radon Disclosure Form that has been drafted pursuant to the statute for approval by the Real Estate Section and the Bar Association for real estate brokers to use in buy/sell transactions. This is a result of the radon disclosure statute passed in the 2023 legislative session. Mr. Cox indicated that this solves a hole where the Seller does not provide the Seller's Property Disclosure, but they still have the statutory requirement to make the Radon Disclosure. Mr. Cox will replace references to tenant with buyer and a couple of additional typos. Ms. Topelson moved to approve with the suggested edits. Mr. Aldrich 2<sup>nd</sup> the motion, and the form was approved unanimously.
- c. Uniform Unlawful Restrictions in Land Records Act.......Adam Aldrich, Tyler Mounsey, and the Records Redaction Task Force Members
  - i. Mr. Tyler Mounsey explained that the Uniform Laws Committee meeting will cover more than just this real estate issue. Ms. Lisa Connolly summarized the uniform law as providing several means for removing prohibited provisions from chain of title to real property, which is more broad than our current statute. Ms. Connolly explained that the law presents concerns because a party may unilaterally change the real estate records without all parties involved in the process. Ms. Connolly noted that the act still does not remove these documents with offensive clauses from the chain of title, thus limiting the practical benefit. Ms. Robin Nolan reminded the group that we came to this same conclusion when we reviewed the issue for Colorado law two years ago. Mr. Adam Aldrich will attend the meeting Friday and present our concerns without taking a formal position.

    - i. Mr. Mounsey gave the issue to the contract lobbyist, and the Council should have an update soon once the legislator that the AG's office is working with on the legislative fix provides an update.
  - c. HB22-1137: HOA clean up bill to address the treatment of violations, posting, notification challenges, and payment plans.

- i. Mr. Mounsey explained that the Governor's legislative task force on this was appointed last week, and their first meeting is October 24<sup>th</sup>. Mr. Mounsey will send the Council the list of people on the task force once he has it.
- d. <u>Fairways at Buffalo Run</u>: Tyler Mounsey and Chuck Clavin met with Rep. Lindquist the drafting of proposed legislation addressing the issues created by the decision
  - i. Mr. Mounsey indicated that the proposed legislative language from the Legislature's drafting attorneys is not yet available to review.
