CBA TRUST AND ESTATE SECTION STATUTORY REVISIONS COMMITTEE MINUTES

February 6, 2019

1. Welcome and Introductions

Timothy Bounds called the meeting to order at 1:45 p.m. There were introductions from those in attendance and on the phone.

2. Approval of November 15, 2018 Minutes

There was no meeting of SRC in January; the minutes from the December 2018 meeting were unanimously approved.

3. Announcements

The New Lawyers study group is still meeting on the first Thursday of each month. Anyone interested should contact Allison Leary.

David Kirch is always accepting new articles (or ideas for articles) for the *Colorado Lawyer*. Please contact Dave if you have a topic or article for submission.

4. Legislative Report – Jeremy Schubach

The guardianship "bill of rights" legislation has been introduced, but any action on the bill will be postponed indefinitely pending further review by the CBA. The sponsors for the bill are Rep. Ransom and Sens. Hulbert and Melton.

The Colorado Uniform Directed Trust Act has moved forward (from "committee" status). Kevin Millard, Kelly Dickson Cooper, and Stan Kent testified before the legislative committee prior to the committee's vote to move the bill forward.

The bill which would establish an electronic storage mechanism for advanced directives and other medical documents passed a Senate committee vote. Jeremy discussed that one important aspect of the proposed bill is that lawyers cannot upload documents; only physicians may access the storage system. Patients would also need to sign an acknowledgment that an electronically stored advanced directive supersedes any other <u>electronic</u> version only.

The "safe families" legislation is now in Title 26, and has been removed from the Probate Code. Jeremey gave a quick status report on negotiations between the various stakeholders.

The proposed remote notary legislation is still missing safeguards that were requested by various stakeholders, specifically those suggested by the Trust & Estates and Elder Law Sections of the Bar. Sen. Duran has proposed an amended version that addresses those concerns/safeguards. A motion to approve the Duran version of the remote notary bill was made, seconded, and passed unanimously by SRC.

Jeremy and Tim Bounds updated the committee on the status of the Colorado Abandoned Estate Planning Documents Act.

5. **SRC Approved Proposals**

a. Active Matters - Work to Finalize Required

(i) UTC Subcommittee (Connie Eyster, Co-Chair)

The Subcommittee is still reviewing the creditor provisions of the UTC.

b. <u>Inactive Matters Approved by SRC but Not Moving Forward for Various Reasons</u>

There are currently no inactive matters approved by SRC but not moving forward.

6. <u>Unapproved Matters under Consideration by SRC – Reports from Subcommittees</u>

a. Legislation Review Joint Subcommittee (Michael D. Holder, Chair)

Michael gave a report to SRC on the proposed revisions to disability trusts. The proposed legislation would affect payment to CO Medicaid as well as Medicaid in other states, and also affect termination provisions at the death of the primary beneficiary. Michael will continue to monitor the progress of this proposed bill.

b. Advance Legislative Response Team (Marco Chayet and Letty Maxfield, Co-Chairs)

There was no report for this Subcommittee.

c. ADR Legislation (C. Jean Stewart, Chair)

There was no report for this Subcommittee.

d. Uniform Fiduciary Income and Principal Act Subcommittee

Georgine Kryda gave a report that the subcommittee continues to review the Act and is making steady progress.

e. Uniform Guardianship, Conservatorship, and Other Protective Arrangements Act

There was no report for this subcommittee.

f. Child Support in Probate Subcommittee (Pat Mellenn, Chair)

Pat introduced Jim Bailey as the new liaison between the domestic section and SRC. Pat also gave an update on the subcommittee's progress.

7. **Inactive Matters**

There were no inactive matters for consideration.

8. Report from Elder Law Section – (Mallory Hasbrook – liaison)

Mallory gave an update on the proposed bill affective disability trusts and said the Section will vote by e-mail on the proposed legislation. Mallory also reported that LPC did not vote to support the "behavioral health" legislation, and that Elder law will work to make changes.

9. Report from Other Sections of the Bar

There were no reports from other sections of the Bar.

10. New Matters

a. Rule Against Perpetuities/Delaware Tax Trap

Tim Bounds will speak with Susan Boothby and John Brine on how they want to move forward with this matter.

b. Living Will/Anatomical Gifts (Carl Stevens)

Carl Stevens discussed forming a subcommittee to eliminate the need for advanced directives and anatomical gift forms to be witnessed. Nursing home/assisted living facilities and hospitals will not let their employees or other residents witness these forms.

Spencer Crona discussed forming a joint subcommittee with the Elder Law Section regarding issues with Adult Protective Services handling of professional fiduciary fees. Currently, a professional fiduciary has no due process for responding to a notice from APS that they have been "red flagged" for financial exploitation due to their fees.
