### 1 Approval of Minutes of Prior Meeting

a. Probate Bench Book – Project is moving forward slowly. May need to find additional authors. Need completed sections to submit to Judge Leith.

#### 3 New Business or Requests

a. Norv Brasch raised issues regarding the quality of virtual court proceeding, ranging from basics such as virtual etiquette, technological issues, diminution of advocacy, difficulty communicating with clients virtually as well as procedural hurdles in raising objections and submitting evidence to the court. Several committee members shared their virtual court experiences, the good the bad and the ugly. Many opined that they believe that judges are also very frustrated with the virtual experience.

Committee members thought it would be helpful if the judiciary could establish uniform basic procedures for virtual hearings and trials.

Next Steps: Marcie McMinimee agreed to reach out to state judicial court administration personnel to address the problem
