# I. Chair's Report

# II. Updates/Reports

<u>Statutory Revisions for E-Wills</u> – Letty gave update. Had first meeting, met with folks from financial institutions. Discussed lodging systems for Ewills. Committee decided worth considering reopening conversation, maybe something similar to Trust Registration Statements. Like a Notice of Execution of Ewill, and would give location where it is stored. Group has reached out to Judicial Branch/Secretary of State. Meeting every 3 weeks on Wed mornings. Next meeting is 9/10, then 10/8, remotely. Reach out to Letty if interested in joining/being involved.

- <u>Unauthorized Practice of Law</u> Tammy gave update. Meetings by Zoom, last Tues of month at 11 am, except for December, Dec 3<sup>rd</sup> Tuesday. Notes will be posted on webpage. First meeting discussed what end goal should be some kind of clear guidance for prof. fiduciaries from OARC what can they file/what not where is the line. Issues with hospitals/financial institutions having patients/clients signing POAs/living wills, etc. No opinion back from John Gleason, former head of OARC. Medicaid Specialists counseling people on how to gift. Susie looking at National trends, reaching out to NALA. What are more rudimentary functions, because there are professional guardians that take cases with small pay/minimal pay, csvs with small estates.
- <u>Mandatory Mediation / 16.1 Committee</u> Spencer and Herb Co-Chairing Had first meeting. Spencer gave update. Concluded that best to get perspective from judiciary, Judge Leith and other judges going to send email inviting them to a panel discussion on both of those issues. Next meeting is scheduled.
- <u>UGCOPPA</u> Letty and Andrew Co-Chairing Letty gave update. Disability Co/ARC – want to run UGCOPPA this year. Bar has already reviewed in past, mixed reviews, but no political will to move forward then, is now. Letty and Andrew meeting with stakeholders October 9 discuss further – what they are envisioning and its timeline. Very large statutory rewrite if all of it is to be implemented.
