Welcome/Introductions

The minutes of the November 1, 2023, meeting were approved.

I. Chair's Report

• Annual Holiday Party later today – Judges on panel will be Judge Vriesman, Judge Leith, and Judge Kramer.

II. Updates/Reports

- <u>Statutory Revisions for E-Wills</u> Stan Kent gave update. Working on proposed statutes, in drafting. Wanting to get wrapped up quick to present to sections.
- Wrongful Death Subcommittee Aaron Evans gave update. Met last week, narrowed down to 6-7 states, working on pulling language from other states' statutes. Meeting again in two months.

- <u>Court Visitor Subcommittee</u> Connie Lind retiring. Aaron reaching out to new person.
- <u>Unauthorized Practice of Law</u> Tammy and Susie gave update. Next meeting is on January 19, 2024, then Feb 2, 2024, both at CFPD offices (2 hours, in person). Working on narrowing down talking points in terms of what we want to get to OARC. Research ongoing into other states' approaches.
- <u>Mandatory Mediation / 16.1 Committee</u> Spencer gave update. NY statutes could provide good foundation for at least a pre-objection discovery process in light of Everhardt case. As far as mediation, the input received is that judges prefer it to be in their discretion.
- <u>County Bench Bar</u> Angela Rockwood / Kris Zumalt gave update. Magistrate Allen confirmed 3/6/2024, going to circulate email with details.
 - February 7th from 10:30-11am: 1st Judicial District, Magistrate Allen (potentially Judge Vriesman as well he will confirm later in January 2024)
 - March 6th from 10:30-11am: 19th Judicial District, Magistrate Apostoli (tentative will confirm later in January 2024 whether it will be her or another judicial officer)
 - o April 3rd from 10:30-11am: 20th Judicial District, Judge Collins
- <u>UGCOPPA</u> Andrew Rogers gave update. Have been meeting weekly on Fridays in person at offices of Wade Ash, 1:00-3:00 have been reading through the act, taking note of issues a we go through it. Uniform Law Commission is convening at the capital this coming Friday morning Andrew and Letty to testify and give them update on our progress and some of issues we've discussed, like forms/how affects other statutes, etc.

III. New Business

- Discussion of Terri Schiavo documentary.
- Judge Werner and Magistrate Rahaman presented to the group starting at approximately 10:30 a.m.
 - a. Rahaman 3000 probate cases filed every year in El Paso County. Most of litigation is focused on estate and trust litigation.
 - i. When disputed cases on radar, calls up cases on case mgt/case scheduling conference. Allows them to get fingers on pulse of the case, goes through deadlines –

- discovery/depositions/exhibits/witnesses/ex and witness lists, etc. finds that helps resolve discovery disputes/reduce discovery requests.
- ii. 10-15 cases per month get kicked up to Judge Werner, either by request or by decision of Magistrate.
- b. Werner Usually when case comes up, a lot of stuff has gone on beforehand. So he requires that attorneys set CMC in his division, he finds out issues and plans going forward, then issues the CMO with deadlines. Sometimes will have another status conference 30 days out from trial/evidentiary hearing to see if any outstanding issues/remove any roadblocks to matter proceeding to hearing. The CMO requires parties to set ADR before trial readiness conference rare that he waives ADR.
- c. Rahaman lots of cases resolve at mediation once case has settled down/discovery is conducted, mediation can be successful.
- d. Werner mandatory ADR order in El Paso since 1996 for any civil case that proceeds to trial. ADR to be completed by pre-trial readiness
 - i. Tone/temperature of case in terms of timing of mediation
- e. Marco R40 Rahaman fine tuning discovery to be specifically related to the case goes to importance of CMC sometimes counsel will agree to incorporate CRCP into discovery schedule discuss that at the case management conference.
- f. Werner will ask what is key issue/issues civil atty sometimes want full discovery, but that will cost estate money. Need to narrowly tailor discovery to the discrete issues.
- g. Probate Breakfast Sheet points
 - i. Point 3 Urge that in motions/oral argument get right to the point for the court.
 - 1. Guide to counsel for arguing before the Supreme Court *Guide for Counsel* can download PDF online.
 - ii. Info of appointment must be on file before letters testamentary issued probate bench decided that.
- h. Werner when you file motion to withdraw, have to comply with Rule 121.

i. Have to confer, in best interest to do so – if unopposed then could get order back same day. Don't need to conferral on Withdrawal motion.
