SECTION 2: CBA RESOURCES

1. Super Thursday

Elder Law and Trust & Estate Section take over the 9th Floor of the CBA offices every third Thursday of the month (except for June & July) for section and committee meetings. Super Thursday is a "must" for any new practitioner wanting to learn more about the T&E field in Colorado. Participation in these committees and subcommittees is open to all Section members and is encouraged. A call-in option is available for most meetings held on Super Thursday. For specific information, see the T&E webpage at www.cobar.org or contact the Chair of the committee you are interested in attending.

Summaries of some of the larger committees and projects are below.

<u>Statutory Revisions Committee</u>: The Statutory Revisions Committee ("SRC") is the largest standing committee of the T&E Section. As its name suggests, this Committee's principal function is to critically examine and, when needed, draft revisions to existing probate law for consideration by the Colorado legislature. This committee also considers proposals for new probate laws. In order to accomplish that, SRC forms subcommittees to debate, draft, and promote changes to Colorado's probate statutes. Each subcommittee's work product is then considered for approval at the monthly meeting of SRC.

<u>Orange Book Forms Committee</u>: Members of the Orange Book Forms Committee draft, review, and revise forms and notes on use for publication in *Colorado Estate Planning Forms*, also known as the *Orange Book Forms*, published by CLE in Colorado, Inc. Due to constant changes to state and federal law, this Committee continually updates its forms.

<u>Rules and Forms Committee</u>: The Rules and Forms Committee reviews and revises the probate Judicial Department Forms (JDF) and the Colorado Rules of Probate Procedure (CRPP). Revisions to the JDF Forms are sent onto the State Court Administrator's Office (SCAO) for approval and posting on the Colorado State Judicial Branch website.

<u>Civic and Community Affairs Committee</u>: The Civic and Community Affairs Committee is responsible for most of the T&E Section's public education endeavors. This Committee assists with updates to brochures offered to the public by the CBA on topics that include "So Now You Are a Personal Representative," "So You Are a Trustee," "What to do When Someone Dies," and "Probate in Colorado." These brochures are available at

<u>www.cobar.org</u>. The T&E Section also helps sponsor the annual Senior Law Day, and annual publication of the *Senior Law Handbook*, which is also available on the website.

<u>CLE Committee</u>: The CLE Committee brainstorms ideas and speakers for upcoming CLE programs, including the annual T&E Update, the Estate Planning Retreat and special programs. The Committee works in conjunction with CLE in Colorado, Inc. The Committee welcomes ideas for CLE topics and speakers.

SECTION 3: CBA CLE PROGRAMS

1. Helpful CLE Programs

Estate Planning Basic Skills and Estate Administration Basic Skills are two-day programs designed for attorneys who want to learn critical basic skills in estate planning or estate administration. Please visit <u>cle.cobar.org</u> for more information or contact CLE at <u>cle@cobar.org</u>.

a. Estate Administration Basic Skills

This program is held in <u>odd</u> years (2015, 2017, etc.) and provides an overview of the essential steps to administer an estate. Past programs have covered the following:

- Creditors' Claims
- Real Estate Matters
- Ethics and Advising the Fiduciary

b. Estate Planning Basic Skills

This program is held in even years (2014, 2016, etc.), and addresses the planning and drafting process, ethical concerns, transfer tax issues, planning for small estates, and more. A part of the program includes session in which the members of the faculty apply the concepts just taught to typical client fact patterns. Past programs have covered the following:

- Information Gathering and the Initial Client Interview
- Introduction to Transfer Taxes
- The Planning and Drafting Process
- Execution of Document and Follow-up Issues
- Planning for Disability
- Planning for Single Clients and Smaller Estates
- Planning For Married Client and Larger Estates
- Revocable Trusts
- Introduction to Marital Deduction

c. Elder Law Basics

This is a half-day program held in odd years (2015, 2017, etc.) and provides an overview of the ever-evolving area of elder law and how it intersects with other practice areas. Past programs have covered the following:

- Understanding Powers of Attorney
- Guardianships and Conservatorships
- Medicaid/SSI/Special Needs Trusts and Disability Trusts
- Medicare/SSDI

d. Probate Litigation Practicum

This recurring program provides the opportunity to practice the elements of courtroom evidence that are important for probate practitioners to know. Participants learn the evidentiary techniques as a larger group then break into small groups for role-playing and discussion. A faculty member coach leads each small group to give individual attention and feedback.

e. Colorado Real Estate Practice

This course is offered annually in the fall and consists of 10 classes taught by Willis Carpenter. Mr. Carpenter has been teaching this program for more than 35 years and it is recognized as the best basic skills course in the Colorado real property law area As a T & E practitioner, real estate is often the most valuable asset most of our clients own. An effective T &E practitioner should develop the ability to issue spot when dealing real estate matters.

Throughout the course, you will an understanding of real estate law in Colorado including farm and ranch issues, mountain vacation property and Torrens.

2. Retreats / Conferences

The annual Estate Planning and Elder Law retreats are key events of the year for probate practitioners, and they are wonderful opportunities to learn more from the experts and to network with practitioners. a. Estate Planning Retreat

This retreat is held annually in June. The 2013 Retreat was held in Snowmass, CO, and the 2014 Retreat will be held in Steamboat Springs, CO. At least one retreat topic is presented to specifically address the needs of

new T&E lawyers. The Unprogram is another opportunity to ask questions and acquire basic information.

b. Elder Law Retreat

This retreat is held annually in August. The 2013 Retreat was held in Vail, CO, and the 2014 Retreat will be in the same location.

c. National College of Probate Judges Spring Conference

The National College of Probate Judges' (NCPJ) membership is open not only to probate judges but also to registrars, clerks, attorneys, financial advisors, law professors, banks, and more. The NCPJ Spring Conference is a great opportunity to meet and network with probate judges and others from across the US and to attend CLE sessions. Registration for the Spring Conference includes a 1-year membership to the NCPJ.

d. Senior Law Day

<u>Senior Law Day</u> is a one-day, annual education seminar for seniors and their caregivers in the Colorado community. Senior Law Day in Denver hosts approximately 800 attendees and over 40 workshops and presentations by experienced senior education professionals. Topics such as powers of attorney, assisted living and nursing home issues, Social Security, and Medicaid basics are covered.

Senior Law Day is held in July and August in various locations around the state, including Denver, Jefferson, Boulder, Larimer, El Paso, Pueblo, and Routt Counties. The Senior Law Handbook, which covers important topics for seniors, is distributed at the events.

SECTION 4: BUILDING THE ESSENTIAL T & E LIBRARY

1. The Green Book

The two-volume <u>Green Book</u> is a yearly publication that contains relevant probate statutes, probate court rules, and probate forms in one place. It is a portable, all-in-one resource for trust and estate and elder law attorneys. An electronic copy (CD-ROM) is included with your purchase.

2. Colorado Estate Planning Handbook and Colorado Estate Planning Forms ("The Orange Books"):

a. Colorado Estate Planning Handbook

The <u>Colorado Estate Planning Handbook</u> is a comprehensive treatise on Colorado estate planning law and is frequently used in conjunction with the <u>Colorado Estate Planning Forms</u> book. The chapters in the Handbook are authored by many of the leading trust and estate attorneys in Colorado. An electronic copy (CD-ROM) is included with your purchase.

b. Colorado Estate Planning Forms

<u>Colorado Estate Planning Forms</u>, commonly known as "*The Orange Book Forms*," includes the most frequently used estate planning forms with accompanying explanatory notes on use. It is an indispensable resource to beginning and experienced estate planning attorneys. An electronic copy (CD-ROM) is included with your purchase.

Get Involved: Attend the Orange Book Forms Committee meetings on Super Thursday at 12:15-1:30pm. Members of this Committee draft, review, and revise forms and notes on use for the Colorado Estate Planning Forms book.

3. Colorado Probate System

Written by former Denver Probate Judge, James R. Wade, <u>Colorado Probate</u> <u>System</u> provides a step-by-step process for estate administration in Colorado. The book contains checklists, forms, letters and deadlines to guide the

practitioner through all aspects of estate administration. An electronic copy (CD-ROM) is included with your purchase.

4. Colorado Law of Wills, Trusts, and Fiduciary Administration

Also authored by James R. Wade, <u>Colorado Law of Wills, Trusts, and Fiduciary Administration</u> is a comprehensive treatise based on *Colorado Probate Practice Manual* by the late Howard E. Parks. It provides a thorough commentary on the law of wills, trusts, and fiduciary administration, focusing on leading Colorado cases, the Colorado probate code, and related fiduciary statutes.

5. Senior Law Handbook

The <u>Senior Law Handbook</u> is a yearly publication that covers a wide range of topics concerning elder law, trust and estate law and aging in general. Although the handbook is targeted toward non-lawyers, the dozens of topics covered in the handbook provide a good overview and starting point for new elder law and trust and estate practitioners. Many of the chapters are written by prominent, experienced members of the <u>Elder Law</u> and <u>Trust and Estate</u> Sections.

SECTION 5: PRACTICE MANAGEMENT RESOURCES

1. CBA Website Resources

The CBA website is an important resource for new lawyers. It is a great place to look for answers to practice management questions and connect with other lawyers. Below are some of the resources available at the CBA website. You can explore these and more at cobar.org.

a. Law Practice Management:

The <u>Law Practice Management</u> group at the CBA has a variety of resources to help members with practice management issues including information and resources regarding general practice management, technology, marketing and finance. For more information, contact Reba Nance at reban@cobar.org.

b. Casemaker:

The CBA provides its members with access to the Casemaker legal research tool, a less expensive alternative to Westlaw. The basic version is free to CBA members, and can be accessed through the <u>CBA Casemaker website</u>. Training on how to use the program is also available.

c. CBA lending library:

The Law Practice Management group at the CBA has a lending library for CBA members. The large catalog has books on topics such as practice management, marketing, technology and finance. The catalog can be viewed <u>online</u> at the CBA website, and books can be borrowed in person or by mail. A list of suggested books for T&E attorneys in the CBA lending library can be found here.

d. CBA member discounts:

The CBA has arrangements with a wide range of legal, business, financial, insurance and personal service companies to provide services to CBA members at discounted rates. These services can be found in the "Member Marketplace".

e. Listservs:

The CBA supports several <u>listservs</u> which provide forums for members to ask questions and participate in discussions on legal issues with their peers, or discuss job opportunities, technology tips, and other topics.

f. CBA Economic Survey:

CBA publishes a biennial survey of the Colorado legal community that gives members a detailed picture of attorney income, staff compensation, billing rates and overhead costs for attorneys practicing in Colorado. The results from these surveys can be found at cobar.org/economicsurvey.

g. Find A Lawyer:

The CBA maintains an <u>online directory</u> of attorney profiles, lawyers searching for employment, and lawyers looking for Of Counsel relationships.

h. CBA Ethics Hotline:

Members of the <u>CBA Ethics Committee</u> are available to discuss ethics questions by phone. The Ethics Committee also accepts written inquiries. Details for contacting the Ethics Committee are available on the CBA website.

2. Other Resources

a. Hanging your Shingle CLE

<u>"Hanging Your Shingle"</u> is a three day CLE that covers all aspects of starting your own practice. This is an essential CLE for lawyers thinking about starting their own practice. Topics are presented by practitioners who have gone out on their own and know the ins and outs of starting a practice. The instructors provide practical advice and information on resources needed to successfully start a practice.

b. Solo-Small Firm Practice Section

The <u>Solo-Small Firm Practice Section</u> provides a forum to address issues unique to solo practitioners and attorneys in small firms. The section provides practical programs dealing with the nuts and bolts of owning a law practice. The section also sponsors a blog (<u>SOLOinCOLO</u>), CLEs, and a listserv for its members. These services and others give members an opportunity to network and share expertise with other solo and small firm practitioners.

c. Young Lawyer Divisions

A "Young Lawyer," as defined by the CBA is any member of the Colorado Bar Association in good standing, who is under the age of 37 or who has been admitted to their first Bar for less than five years. All Colorado lawyers who fall into either of these categories are automatically enrolled as members of the Young Lawyers Division (YLD). The YLD hosts events opportunity for young lawyers to become involved in the bar and network with other young attorneys. Details about YLD can be found at cbayounglawyer.org.

d. Metropolitan Lawyer Referral Service

Metropolitan Lawyer Referral Service, Inc. (MLRS) is a non-profit service and the only bar-sponsored lawyer referral service in Front Range Colorado. MLRS pre-screens attorneys and connects the members of the public to an attorney in a specific area of expertise. e. Local Bar Associations

Active members of the Colorado Bar Association living in Colorado are required to become members of a local bar association. If you are not certain which local bar association you belong to, there is a <u>list of local bar associations</u> on the CBA website which provides the geographical boundaries of each local bar association. CBA members may join more than one local bar association. Local bar associations sponsor activities, such as: pro bono services, senior law days, law days and other activities.

Tip: Local bar associations provide an opportunity to meet and network with attorneys in your community.

SECTION 6: HOW TO GAIN EXPERIENCE AS A NEW TRUST & ESTATE / ELDER LAW LAWYER

1. CLE Retreat Programs

There are a myriad of CLEs, seminars, homestudies, and books available in the trusts and estates and elder law areas, which can supplement or boost your knowledge in a particular subject. In addition, the Estate Planning Retreat (held in June of each year) and Elder Law Retreat (held in August of each year) are excellent opportunities to learn about the "hot topics" in the field and to network with some of the most experienced and knowledgeable trusts and estates professionals in Colorado. 2. Colorado Lawyers for Colorado Veterans

The Colorado Bar Association, in cooperation with a number of local bar associations, offers legal services for veterans across Colorado. The clinics provide free and low-cost legal services to military veterans. Please visit Colorado Lawyers for Colorado Veterans website for more information.

3. Metro Volunteer Lawyers (MVL)

Metro Volunteer Lawyers' Mission is: "To bridge the gap in access to justice by coordinating the provision of pro bono legal services by volunteer lawyers within the Denver Metro Area to people who could not otherwise afford legal services for their civil legal issues." MVL provides opportunities for new practitioners to take on clients on a pro bono or low-fee basis and to gain experience in client representation.

Volunteers are needed to help ensure that people in need get professional legal representation for their civil cases. MVL will help identify a client in need who has a case that fits within the practice and geographic areas that you want to help with. 4. Pro Bono Project/ Colorado Legal Services

The mission of <u>Colorado Legal Services</u> is to provide meaningful access to high quality, civil legal services in the pursuit of justice for as many low-income persons and members of vulnerable populations throughout Colorado as possible. For more information, visit coloradolegalservices.org.

5. Colorado Lawyer's Committee

Founded in 1978, the <u>Colorado Lawyers Committee</u> is a nonpartisan consortium of 59 Colorado law firms dedicated to creating and increasing opportunities for children, the poor and other disadvantaged communities through advocacy, negotiation and litigation. The Colorado Lawyers Committee usually has 20 active projects in the areas of: poverty and public benefits, civil rights, education, immigration, community development, and criminal law. 6. Guardian Ad Litem (GAL) And Court-Appointed Counsel (CAC) Appointments

Serving as a guardian ad litem and/or Court-Appointed Counsel in a protective proceedings or a decedents' estate case is a great way to gain experience and insight into courtroom procedures and case process from start to finish. Each district maintains a list of GAL/CAC appointments, and interested practitioners should contact the specific court for more information on the process and requirements for being added to the appointment list. Practitioners are also encouraged to contact experienced practitioners already serving in the GAL/CAC role for opportunities to observe them in action. This is also a great opportunity to build a working relationship with experienced practitioners in the field.

7. Volunteer Probate Attorney Clinic at the Denver Probate Court

The Denver Probate Court holds a volunteer probate attorney clinic every Mondays and Wednesdays from 1:30 – 3:30PM. New attorneys can be paired with seasoned volunteer attorneys to gain experience with providing legal counsel. Contact Julia McVey for more information.

8. Colorado Attorney Mentoring Program (CAMP)

The <u>Colorado Attorney Mentoring Program</u> was created by the Chief Justice Commission on the Legal Profession and is housed within the office of the Colorado Attorney Regulation Counsel. CAMP helps new Colorado attorneys "acquire legal skills and develop an ethical and professional 'identity' by paring them in mentoring relationships with experienced Colorado attorneys."


